INDIAN VETERINARY COUNCIL ACT, 1984. No.GHKH/28/2022/VHD/10/2020/1063/P1: - In exercise of the powers conferred by section 65 of the Indian Veterinary Council Act, 1984 (52 of 1984), the Government of Gujarat hereby makes the following rules further to amend the Gujarat Veterinary Council Rules, 2007, namely:-

- 1. (1) These rules may be called the Gujarat Veterinary Council (Amendment) Rules, 2021.
  - (2) They shall come into force on the date of their publication in the *Official Gazette*.
- 2. In the Gujarat Veterinary Council Rules, 2007 (hereinafter referred to as the said rules), for the heading "Part 1" shown the heading "Chapter I" shall be substituted.
- 3. In the said rules, in rule 2, in sub rule (1)
- (i) For clause (g), the following clause shall be substituted, namely:-
  - (g). "President" means the President of the Gujarat State Veterinary Council:"
- (ii) For clause (l), the following clause shall be substituted, namely:-
  - (l) "Gujarat State Veterinary Council" means the council established under section 32 of the Act;
- (iii) After clause (l), the following clause shall be added, namely:-
  - (m). "Vice President" means the Vice President of the Gujarat State Veterinary Council;
  - (n). "State Government" means the Government of Gujarat."
- 4. In the said rules, for the words "State Veterinary Council" and "State Council", wherever they occurs the words "Gujarat State Veterinary Council" shall be substituted.
- 5. In the said rules, after Chapter I, the following Chapter and rule -2(A) shall be inserted there under namely:-

#### "Chapter - I(A)"

- "2(A). The Gujarat State Veterinary Council shall consist of the following members:
  - (1) Four Members elected from among themselves by Veterinary Practitioners registered in the Gujarat State Veterinary Register;

- (2) Dean/Principal of any two recognized veterinary institutions of Gujarat, which are included in the First Schedule of the Act, *ex-officio*;
- (3) Three Members to be nominated by the State Government;
- (4) The Director of Animal Husbandry, Gujarat State, Gandhinagar, ex-officio;
- (5) One Member to be nominated by the Gujarat State Veterinary Association;
- (6) Registrar of the Gujarat State Veterinary Council, ex-officio;
- (B). The names of persons nominated or elected as members shall be notified by the State Government in the *Official Gazette*.
- (C). A person shall not be qualified for nomination for election as a member of the Gujarat State Veterinary Council unless he holds a recognised veterinary qualification."
- 6. In the said rules, in rule 4, in sub rule (3), the following sub rule shall be substituted, namely:-
  - "(3). Publication of the draft Roll:- The Registrar shall publish the draft roll prepared under rule 3 by making copies thereof, available for inspection and displaying it in the office of Gujarat State Veterinary Council and on Official Website of Gujarat State Veterinary Council."
- 7. In the said rules, in rule 6, in sub rule (2), the words "and on Official Website of Gujarat State Veterinary Council." shall be added at the end.
- 8. In the said rules, in rule 13, in sub rule (3), the following sub rule shall be substituted, namely:-
  - "(3). The said list shall be published in the *Official Gazette* and given wide publicity in a manner as the Returning Officer deems fit."
- 9. In the said rules, for rule 14, the following rule shall be substituted, namely:-
  - **"14. Voting:-** (1) If the number of duly nominated candidates for election does not exceed the number of members to be elected, the Returning Officer shall forthwith declare such candidates duly elected.
  - (2) If the numbers of such candidates exceed the number of members to be elected, the Returning Officer shall fix a period of not exceeding seven days for election of members through online voting.

- (3) For online voting, the eligible voter has to follow the following procedure, namely:-
  - (i) he may login with his registration number in the Gujarat veterinary register;
- (ii) after login, he shall receive one time password (OTP) on his mobile number registered with the Gujarat State veterinary council;
- (iii) on entering such onetime password, the voter shall be able to see a list of contesting candidates and then he may vote by ticking (✓) as many candidates as there are seats to be filled by the election;
- (iv) after voting, voter shall get an acknowledgment that he has completed the voting process successfully;
- (v) after voting, voter shall be automatically logged out and re-voting shall not be possible."
- 10. In the said rules, rules 15 and 16 shall be deleted.
- 11. In the said rules, for rule 17, the following rule shall be substituted, namely:-
  - **"17. Counting of votes.**—(1) The Returning Officer shall, on the date and time fixed by him for this purpose, enter the password and get the number of votes received by each contesting candidates.
  - (2) Any contesting candidate or his representative duly authorised in writing by him may remain present in person to watch the process of counting."
- 12. In the said rules, for rule 18, the following rule shall be substituted, namely:-
  - **"18. Declaration of result.**—(1) The Returning Officer shall prepare a list of candidates in order of highest votes polled and declare the candidates elected, in that order according to the number of seats to be filled up.
  - (2) When there is equality of votes among any two or more candidates, the candidate who shall be deemed to have been elected shall be determined by lots to be drawn by the Returning Officer in such manner as he may decide.
  - (3) The Returning Officer shall, as soon as the result is declared, inform each successful candidate being elected to the Council.
  - (4) If any candidate declared elected under sub-rule (1) refuses to act as a member, then in the place of that candidate, one of the remaining unsuccessful candidate to whom the

- next largest number of votes have been polled, shall be deemed to have been elected and the same procedure shall be adopted as often as any vacancy is caused in this way.
- (5) Retaining of Election documents:- After declaration of results, the Returning Officer shall preserve all the documents relating to election for a period of six months and shall not destroy, after this period, without the previous concurrence of the State Government."
- 13. In the said rules, in rule 20, for the word and figures "Form IV" the word and figures "Form VI" shall be substituted.
- 14. In the said rules, for rule 21, the following rule shall be substituted, namely,
  - **"21. Procedure for election of the President:-** (1) The election of the President of the Gujarat State Veterinary Council by the members of the Gujarat State Veterinary Council from amongst themselves shall be held at the first meeting of the said Council within one month after its constitution or re-constitution, as the case may be.
  - (2) The Registrar of the Council shall perform the functions of the Returning Officer for this purpose. Any member present shall be entitled to propose the name of any other member present, for election as the President. The proposal shall be required to be seconded by a member other than the proposer or the one whose name is proposed.

Provided that one member shall be entitled to propose or second only one name.

- (3) Any candidate may withdraw his candidature before the actual election.
- (4) If the name of only one candidate is duly proposed and seconded, the Returning Officer shall forth with declare such candidate as duly elected.
- (5) If the number of candidates proposed and seconded exceeds one, an election shall be held by Secret ballot.
- (6) Before the commencement of the election, the Returning Officer shall invite the members to inspect the ballot box, in case they like to do so, and he shall then lock the ballot box.
- (7) (a) At the time of actual election, the members present in the meeting shall one by one, sign against their name in the list containing names of all the members in alphabetical order and placed alongside the ballot box.

- (b) After a member has signed against his name in the list afore-mentioned he shall be given a ballot paper which he shall drop into the ballot box after affixing thereon a cross (X) mark against the name of the candidate of his choice.
- (8) As soon as all the Members present and wishing to exercise the right to vote have done so the Returning Officer shall, in the presence of the candidates who may be present in person, open the ballot box and take out from it all the ballot papers, examine them and reject as invalid any ballot paper;
  - (a) if it does not bear the signature of the Returning Officer; or
  - (b) if the member signs his name or writes any word or make any mark on it by which it becomes recognizable as his ballot paper; or
  - (c) if no vote is recorded thereon; or
  - (d) if the vote is recorded in such a manner as to make it doubtful as to which candidate the vote has been given; or
  - (e) if the vote has been given in favour of more than one candidate.
- (9) (a) The Returning Officer shall then proceed to arrange the valid votes according to the candidates in whose favour they have been cast and count them separately for each candidate.
  - (b) After the counting is over, the Returning Officer shall make an announcement in the meeting about the votes secured by each of the candidates.
  - (c) The Returning Officer shall declare, the candidate securing the highest number of valid votes as duly elected to be the President of the Council.
  - (d) In the event of two or more candidates securing the same number of votes and that number being more than the number of votes secured by any candidate other than the two or more securing the same number of votes, the determination as between such candidates shall be draw of lots and the candidate on whom the lot falls, shall be declared elected.
- 10. Election of Vice-President.- The provisions regarding election of President specified in rule 21(1) to 21(9) shall 'mutatis mutandis' apply to the election of the Vice-President."

- 15. In the said rules, in rule 22 for sub-rule (10), the following sub-rule shall be substituted, namely:-
  - "(10). Every meeting of the Gujarat State Veterinary Council shall be presided over by it's President. In absences of the president, the Vice President or in case where both the President and the Vice-President are absent, the meeting of the Gujarat State Veterinary Council shall be presided over by any other member chosen by the members present from amongst themselves."
- 16. In the said rules, in rule 24, for sub-rule (3), the following sub-rule shall be substituted, namely:-
  - "(3). If the office of the President is vacant or if the President for any reason unable to exercise the powers or perform the duties, the Vice-President shall act in his place and shall exercise the powers and perform such duties of the President."
- 17. In the said rules, in rule 25, for sub-rule (4), the following sub-rule shall be substituted, namely:-
  - "(4). The powers and functions of each Committee and its members shall be determined at the time of the constitution of the Committee and unless the Gujarat State Veterinary Council otherwise specifies, each Committee shall have full power, within the sphere of the functions assigned to it, to take decisions;

Provided, that decisions of the Committee shall be subject to ratification by the Gujarat State Veterinary Council."

- 18. In the said rules, in rule 28,
  - (i) for sub-rule (3), the following sub-rule shall be substituted, namely:-
    - "(3). The Council shall issue provisional registration certificate to such graduates who have completed their academic requirements for the Degree course. Every student who has passed all the courses of Bachelor of Veterinary Science and Animal Husbandry (B.V.Sc.&A.H.) program shall, before undergoing internship training, be required to get himself or herself provisionally registered with the Gujarat State Veterinary Council and shall make an application in **Form VII(A)** through the Dean or Principal of the Veterinary College concerned from where he completed academic Course. On

completion of internship training, every graduate shall apply for permanent registration and shall surrender his provisional registration certificate along with application for registration to the Gujarat State Veterinary Council.

Every such applicant, for Registration, shall pay a fee of Rupees Twenty-five only for Provisional Certificate and for Final Certificate of registration separately."

- (ii) for sub-rule (5), the following sub-rule shall be substituted, namely:-
  - "(5). (a) Any person desiring to retain his name in the State Veterinary Register, shall pay renewal fee of fifteen rupees only to the Gujarat State Veterinary Council, every five years before the 1st day of April of the year in which his registration renewal falls due.
  - (b) Where a renewal fee is not paid within the said period, the Registrar of the Gujarat State Veterinary Council shall remove the name of the defaulter from the State Veterinary Register:

Provided that a name so removed may be restored to the said register on payment of renewal fee and for the purposes of restoration of the name under section 50 of the Act shall be twenty-five rupees only"

- (iii) For sub-rule (6), the following sub-rule shall be substituted, namely:-
  - "(6). The fees shall be paid to the Registrar by means of a crossed cheque of any Nationalized Bank drawn in favour of the Registrar, Gujarat Veterinary Council or by Postal Order or by cash payment or through electronic transaction via official website of Gujarat State Veterinary Council."
- (iv) For sub-rule (9), the following sub-rule shall be substituted, namely:-
  - "(9). Transfer of Registration: A Registered Veterinary practitioner of other State who wants to practice veterinary medicine in the State, may apply on payment of fee, to get his name registered in the State Veterinary Register, on application in the Form VII(B) duly recommended by the State Veterinary Council, where he is already registered, to get his name transferred on the State Veterinary Register of the State, where he wants to practice along with no objection Certificate of the State Veterinary Council, where he already registered. The Registrar of the State Veterinary Council shall satisfy himself before transferring his registration that no disciplinary proceedings is pending against

him or for any other reason it appears to him that the application for transfer is not bonafied.

The Registrar of the State Veterinary Council before entering the name of such practitioner shall ensure that he has paid all dues of the State Council from where he is transferring his registration.

The fee for the purpose of supply of No Objection Certificate (as per Form - XI) and recommendation letter on demand, the Veterinarian shall have to pay fifteen rupees only.
