Resolution:

The Gujarat Legislative Assembly had passed a resolution on 29.9.1999 to adopt the Indian Veterinary Council Act, 1984 in the State which has been enforced in Gujarat State from 15/1/2000 by notification of Government of India No. 51-12-90 LTD (VC) dated 12.1.2000. The Director of Animal Husbandry, Gujarat State, Gandhinagar has made a proposal vide letter under reference No.2 to constitute a State Veterinary Council. This matter was under active consideration of the State Government.
