Adverting to the subject and the reference letter it may be recalled that Central Government (DAHD) has issued Gazette Notification for conduct of forthcoming election to VCI and subsequently the RVPs and Registrar of SVCs have been informed to update registered mobile number & email Id of RVPs / Electorals at the office of the Registrar of respective SVC vide Public Notice dated 08.12.2023 and circular dated 18.12.2023 respectively.

Now, the undersigned has been directed by the competent authority to finalize the draft Electoral Roll immediately. Therefore, the relevant portion of the draft Electoral Roll as updated by the O/o VCI is forwarded herewith to the Registrar of the State/UT Veterinary Councils for displaying at the respective offices. The same may also be uploaded on the website of the State Veterinary Council and Animal Husbandry Department for wide publicity and knowledge of RVPs.


As decided, the Registrar of SVCs shall ensure that following tasks on TOP PRIORITY.

1	Publication and display of the draft electoral roll in the office of State / UT Veterinary councils as well in VCI (Under Rule 5 of IVC Rules 1985)	09.1.2024	23.1.2024
-2	Time for the Registrar SVC to compile the objections/ claims/ mobile no/ address etc received from RVPs (Under Rule 6 of IVC Rules 1985)	24.1.2024	8.2.2024

Important note:

1. The Registrar SVCs shall attend to it on Top Priority and ensure correctness of all the details.
2. The Registrar SVC shall submit the final Draft Electoral Roll of the State **under his Seal and Signature** to the office of the VCI, New Delhi latest by **8.2.2024** (6.00pm) for further actions.
3. In the case of each RVP/ Electoral, only one registered mobile number to be considered and duplicity of mobile number to be strictly avoided.
4. It may be noted that the RVPs with no registered mobile number or in complete mobile number in the electoral roll will be automatically deleted from the electoral roll and shall have no opportunity to cast their votes.
5. In the 'Remarks' column of Electoral Roll, the Registrar of State/UT Veterinary Councils will specifically mention as under:
 - a. **Deleted:** If the name of RVP is deleted on account of death / transfer of Registration / cancellation of registration / non-renewal of registration by the RVP.
 - b. **Addition:** If any RVP claims for addition of name or mobile number (separate form is enclosed for this purpose).
 - c. **Up dated:** If the RVP is updating his mobile number.
6. The Registrar SVCs shall not alter the format of Electoral Roll sent from this office. Changes/ updating / correction etc shall be made in the draft electoral roll as provided by this office.
7. If need be, VCI may arrange a virtual meeting with SVCs providing login.
